To Potential Sanctuary Advisory Council Applicants,


NOAA's Office of National Marine Sanctuaries is establishing a Sanctuary Advisory Council for the Proposed Lake Ontario National Marine Sanctuary. We are looking to fill the following seats:

- Citizen At-Large (2 members and 2 alternates)
- Divers/Dive Clubs/Shipwreck Exploration (2 members and 2 alternates)
- Economic Development (2 members and 2 alternates)
- Education (2 members and 2 alternates)
- Maritime History and Interpretation (2 members and 2 alternates)
- Recreational Fishing (2 members and 2 alternates)
- Recreational Boating (1 member and 1 alternate))
- Shoreline Property Owner (1 member and 1 alternate)
- Tourism (1 member and 1 alternate)

In addition, the following government agencies will appoint a non-voting member and an alternate to the Council:

- Oswego County
- Jefferson County
- Wayne County
- Cayuga County
- City of Oswego
- Port of Oswego Authority
- US Coast Guard
- State of New York

Applications are accepted through **November 1, 2019**. The Sanctuary Advisory Council for the Proposed Lake Ontario National Marine Sanctuary was established pursuant to Federal Law to ensure public participation in the development/management of the proposed sanctuary.



Per the charter, voting members and alternates are normally appointed for a term of three years, and may compete for reappointment. If necessary, terms of appointment may be changed to provide for staggered expiration dates or member resignation mid-term.

Please note that if you have been a federally registered lobbyist in the two-year period before your potential appointment date to the council, you will not be eligible to serve as a member of a sanctuary advisory council.
