
NOAA proposes to manage nationally significant maritime heritage resources, including historic shipwrecks. NOAA would work to ensure future generations can learn about and explore these underwater treasures. In partnership with local communities, NOAA would provide a national stage for promoting heritage tourism and recreation to connect more Americans with this special place. NOAA would co-manage the sanctuary with the state of New York.


Boundary Alternative 1

- 43 known shipwrecks
- One known aircraft
- 20 potential shipwrecks and three aircraft


